NOTICE TO DEFENDANTS OF ORDER ESTABLISHING TRAFFIC VIOLATIONS BUREAU

AN ORDER OF THE COURT ESTABLISHING A TRAFFIC VIOLATIONS BUREAU HAS BEEN ISSUED BY JUDGE PATRICIA F. SCOTT:

THIS ORDER AUTHORIZES THE COURT CLERK AS THE TRAFFIC VIOLATIONS BUREAU CLERK, TO ACCEPT APPEARANCES, WAIVER OF TRIAL AND PLEAS OF GUILTY IN CERTAIN OFFENSES. IT ALSO AUTHORIZES THE COLLECTION OF STANDARDIZED FINES ON PLEAS OF GUILTY TO THESE CHARGES.

IF YOU WISH TO PLEAD GUILTY AND PAY THE FINE AND COSTS LISTED BELOW, YOU WILL NOT HAVE TO APPEAR IN COURT.

0 TO 10 MPH OVER THE POSTED LIMIT	\$125.00, plus \$25.50 court cost	\$150.50
11 TO 25 MPH OVER THE POSTED LIMIT	\$199.50, plus \$25.50 court cost	\$225.00
OVER 25 MPH OVER THE POSTED LIMIT IS A MANDATORY COURT APPEARANCE		
DEFECTIVE EQUIPMENT	\$225.00*	
FAILURE TO REGISTER VEHICLE	\$150.50*	
DRIVING WITHOUT LICENSE	\$225.00*	
FAILURE TO WEAR SEAT BELT (NO COURT COSTS)	\$ 10.00	

*THE ABOVE AMOUNTS INCLUDES THE FINE AND COURT COSTS OF \$25.50, WHICH ARE ASSESSED WHETHER OR NOT YOU APPEAR IN COURT. STATE LAW SETS THESE COSTS.

** EXCULDES: C&I OR C&R DRIVING OR CAUSING AN ACCIDENT; DRUG OR ALCOHOL VIOLATIONS; NO PROOF OF INSURANCE; FAILURE TO STOP FOR SCHOOL BUS; DRIVING WHILE SUSPENDED OR REVOKED AND ANY VIOLATIONS REQUIRING RESTITUTION TO A THIRD PARTY. ALL OTHER VIOLATIONS REQUIRE A COURT APPEARANCE.

YOU CAN MAKE PAYMENT AT LAURIE CITY HALL, OR YOU MAY SEND A CHECK OR MONEY ORDER IN THE AMOUNT OF THE FINE AND COSTS, PAYABLE TO "LAURIE MUNICIPAL COURT". YOU MUST ALSO SIGN THE "APPEARANCE WAIVER OF TRIAL AND PLEA OF GUILTY", WHICH APPEARS ON THE BACK OF YOUR TICKET. MAIL THE PAYMENT ALONG WITH THE SIGNED YELLOW COPY OF THE TICKET TO:

THE FINE AND TICKET MUST REACH THE COURT BEFORE YOUR APPEARANCE DATE OR A WARRANT WILL BE ISSUED FOR YOUR ARREST. THE RISK OF NON-DELIVERY OF MAIL IS ON THE DEFENDANT MAILING THE FINE AND TICKET.

NOTHING CONTAINED HEREIN IS INTENDED TO LIMIT IN ANY WAY YOUR RIGHT TO APPEAR, PLEAD NOT GUILTY AND HAVE YOUR CASE HEARD BY THE COURT OR BY A JURY.
