

**REGULAR MEETING MINUTES
BOARD OF ALDERMEN
JANUARY 12, 2016 6:00 P.M.
CITY OF LAURIE, MISSOURI**

Mayor Scott Fahrer called the meeting to order at 6:00 p.m.

Mayor's Communications

Jeff Chorpening was sworn in as temporary Alderman (replacing Val Ites) by Judge Pat Scott. The Mayor presented a plaque to the Laurie Police Department in appreciation for their efforts in securing over \$40,000 in grant money for equipment over the past several years. The award was accepted by Chief Mark Black and Assistant to the Chief, Angela Nickerson. The Mayor presented an award to Officer Nick Shoemate in appreciation of his efforts, including spending \$500 of his own money, to save a dog badly burned in a house fire. The Mayor proposed Alderman Lux to be Mayor Pro Tem in the interim until April elections. Alderman Dobbins made a motion to approve Alderman Lux as Mayor Pro Tem. Alderman Chorpening seconded. Motion passed unanimously.

Approval of Minutes

Alderman Lux made a motion to approve the December 8th regular meeting minutes. Alderman Dobbins seconded. Motion passed unanimously. Alderman Lux made a motion to approve the December 16th work session minutes. Alderman Dobbins seconded. Motion passed unanimously.

Pending Payments & Addition to Pending Payments

Alderman Chorpening asked about an item on page 3 which was a total for the two entries on the previous page. Alderman Chorpening asked about a uniform expense and if it was a monthly expense. Ron Clarke explained it was one of several individual purchases and there were no regular monthly uniform expenses. Alderman Lux asked about a charge to well #2. Dean Smith responded that the expense was for setting up telemetry. Alderman Dobbins moved to approve payments and pending payments. Alderman Lux seconded. Motion passed unanimously.

Sidewalk Update: Ron Clarke reported on an email from Andrew Eckhart, of Anderson Engineering, containing an updated schedule from MODOT. Final plans and estimates from MODOT should be complete by January 15th and that Mr. Eckhart would come to the February meeting to discuss the project.

Tom Hohnecker discussed the 2016 American Legion 9/11 Ceremony and requested permission to have a parade from the mall to the American Legion Hall. The ceremony is held every five year anniversary. The parade will have no walking, only vehicles.

Alderman Dobbins made a motion to allow the ceremony/parade. Alderman Chorpening seconded. The motion passed unanimously.

Craig Gresham expressed a concern about road maintenance. His road is Deer Valley Road which is within the city limits. The Mayor said that there were funds in place to fix the roads and we need to do something. Alderman Dobbins asked if the road was asphalted. The road is gravel. Mr. Gresham responded that city maintenance always stops at the gravel. Mayor Fahrer responded that current ordinance requires the neighborhood to complete the initial paving and that if it meets requirements, the city will take over the maintenance. Steve Grantham interjected that the subdivision may be responsible for paving the road. Mr. Grantham said that if the Mayor so directed he would investigate any covenants or plats that control the situation, as well as any ordinance changes, and report back to the board. Mayor Fahrer asked if Mr. Gresham would come back next month and he agreed.

Mr. Gresham asked why his water bill keeps going up. Alderman Lux asked if he had looked for leaks. Mayor Fahrer stated water rates have not been raised in almost two years. Mayor Fahrer explained how to check for leaks

Scott Craig presented a proposed Citizens' Firearms Safety course for the citizens of Laurie. There was discussion on the City's liability, the no firearms within City buildings ordinance, and how the class could be structured around these issues. Although there was support for the program, Alderman Lux asked that the issue be tabled until next month to investigate liability, to see how much interest there would be, and to allow time to formulate a step by step procedure to make sure there are no un-safe acts.

Susann Huff reported on the Enchanted Village of Lights and that they had taken in over \$30,000.

Mark Black, Police Chief presented the following monthly statistics for December 2015: Traffic Stops 39; Warnings 35; Summons 13; Assist Other Agencies 15; Criminal Activities 2; Calls for Service 294, Arrests 2.

City Clerk

Ron Clarke reviewed the unaudited financial report for December 2015. December total of all funds \$2,170,103. General Fund Revenues - \$671,550; General Fund Expenses - \$511,200; Event Fund Revenues - \$103,415; Event Fund Expenses - \$88,014; Water and Sewer Fund Revenues - \$666,230; and Water and Sewer Fund Expenses – \$504,217.

Sales Tax Review: December City Sales Tax was \$22,022; Year to date: \$377,826. This is a decrease of \$4,782 for the same period in 2014. December Street Sales Tax was \$10,812, YTD \$185,827. This is a decrease of \$2,434 for the same period last year. December Sewer Sales Tax was \$11,010, YTD \$188,913. This is a decrease of \$2,378 for the same period last year.

Ron Clarke reminded the board and citizens that filing for the April election would close next Tuesday January 19th and that Monday was a holiday.

Ron Clarke also reported that the city had sent flowers to Keith Gromer’s funeral.
