This agreement is only a license and may be revoked and terminated by the City and shall not be deemed a tenancy, leasehold, estate or right. If the city cannot make the facility available at the scheduled time, I will be entitled to the return of my deposit and any advance payment, any payment will be refunded with advance notice of cancellation, 10 days prier to date of event. I shall not be entitled to any other
